There are 10 proposed special resolutions to be considered at the 2022 AGM about changing the Rule Book.

Words which are crossed out are proposed to be removed from the Rule Book.

Words which are <u>underlined</u> are proposed to be added to the Rule Book.

Proposed Special Resolution 1: Amend Rule 5.2.4 (Deciding membership applications) as follows:

The members of Bunuba Aboriginal Corporation RNTBC resolve to modify **Rule 5.2.4** of the Bunuba Aboriginal Corporation RNTBC rule book on the same or substantially the same terms as below and agreed by the members at the AGM:

Rule 5.2.4 Deciding membership applications

- (a) The directors will consider and decide membership applications.
- (b) Applications will be considered and decided in the order in which they are received by the corporation.
- (c) Within 14 days of receiving the application, the directors shall refer the application for the consideration and advice of the dawangarri for the relevant muway which the applicant claims he or she is a member.
- (d) The directors of the Corporation will consider and decide the membership application/s by resolution at the next directors' meeting after consideration of the advice of the dawangarri.
- (e) The directors must not accept an application for membership of the corporation unless if the applicant:
- (i) applies according to rule 5.2.3; and
- (ii) meets all the eligibility for membership requirements; or
- (iii) is ineligible after consideration by the applicant's dawangarri.
- (f) The directors must not accept an application if it results in a majority of members being non-Indigenous.
- (g) The directors may not refuse to accept a membership application even if the applicant has applied in writing and complies with all the eligibility requirements.

(fh) HoweverIf the directors refuse to accept a membership application because the applicant does not meet the requirements under rule 5.2.4(e), then the directors must notify the applicant in writing of the decision and the reasons for it.

Proposed Special Resolution 2: Amend Rule 8.2.4 (Consent to act as director) as follows:

The members of Bunuba Aboriginal Corporation RNTBC resolve to modify **Rule 8.2.4** of the Bunuba Aboriginal Corporation RNTBC rule book on the same or substantially the same terms as below and agreed by the members at the AGM:

8.2.4 Consent to act as director

- (a) Before a person may be appointed as a director, that person must:
 - (i) give the corporation a signed consent to act as a director of the corporation <u>in substantially</u> the form set out in Schedule 5; and
 - (ii) inform the corporation of their Director identification number or, if they do not already have a Director identification number, make an application for a Director identification number as required by the CATSI Act.
- (b) The corporation must keep the consent.

Proposed Special Resolution 3: Amend Rule 8.6 (Alternate directors) as follows:

The members of Bunuba Aboriginal Corporation RNTBC resolve to modify **Rule 8.6** of the Bunuba Aboriginal Corporation RNTBC rule book on the same or substantially the same terms as below and agreed by the members at the AGM:

8.6 Alternate directors

- (a) With the other directors' approval, a director (appointing director) may appoint an alternate from his or her muway to exercise some or all of the director's powers for a specified period.
- (b) If the appointing director asks the corporation to give the alternate director notice of directors' meetings, the corporation must do so.
- (c) The appointing director may terminate the alternate's appointment at any time.
- (d) An appointment of an alternate or its termination must be in writing <u>in substantially the form set out in Schedule 6</u>. A copy must be given to the corporation.
- (e) The alternate director must give their consent to be an alternate director in writing in substantially the form set out in Schedule 7. A copy must be given to the corporation.

<u>Proposed Special Resolution 4:</u> Amend Rule 8.8(a) (How to fill vacancies) as follows:

The members of Bunuba Aboriginal Corporation RNTBC resolve to modify **Rule 8.8(a)** of the Bunuba Aboriginal Corporation RNTBC rule book on the same or substantially the same terms as below and agreed by the members at the AGM:

8.8 How to fill vacancies

- (a) If a directorship becomes vacant, the directors may appoint a replacement from the members in accordance with rule 8.2.2(a) until a general meeting is held and a new person appointed in accordance with rule 8.4.1.
- (b) If the office of chairperson becomes vacant before the end of its term, the directors may elect a new chairperson from the remaining directors to complete that term.

Proposed Special Resolution 5: Amend Rule 9.2 (Exercise of powers) as follows:

The members of Bunuba Aboriginal Corporation RNTBC resolve to amend **Rule 9.2** of the Bunuba Aboriginal Corporation RNTBC rule book on the same or substantially the same terms as below and agreed by the members at the AGM:

9.2 Exercise of powers

The corporation shall not exercise a power except to fulfil an object of the corporation and in performing a function or exercising a power shall:

- (a) so as to protect the interests of affected native title holders;
- (b) so as to ensure the maintenance of traditional Bunuba laws and customs;
- (c) so as to minimise, and to the maximum extent practicable avoid, exposing native title holders to claims, actions or debts for which they may be personally liable and
- (d) when making a native title decision, comply with the <u>Regulations</u>. rule 9.3 and make the decision in accordance with the consent and direction of affected native title holders.

<u>Proposed Special Resolution 6:</u> Repeal and replace Rules 9.3.1 (Native title Decisions) and 9.3.2 (Evidence of consultation and consent) as follows:

The members of Bunuba Aboriginal Corporation RNTBC resolve to repeal **Rule 9.3.1** and **Rule 9.3.2** and replace with new Rule 9.3.1 and Rule 9.3.2 of the Bunuba Aboriginal Corporation RNTBC rule book on the same or substantially the same terms as below and agreed by the members at the AGM:

9.3.1 Native title decisions

(a) <u>Before making a native title decision, the corporation must consult with and obtain the</u> consent of the native title holders in accordance with the Regulations.

9.3.2 Evidence of consultation and consent

- (a) As soon as practicable after a native title decision is made, the corporation must prepare a certificate in accordance with regulation 9 of the Regulations and in the substantially in the form set out in Schedule 8. The certificate must be signed by 2 directors of the corporation.
- (b) A certificate prepared and signed in accordance with regulation 9 of the Regulations is prima facie evidence that the corporation has consulted and obtained consent of native title holders as required by regulation 8 of the Regulations.

Proposed Special Resolution 7: Amend Rule 17 (Dispute resolution process) as follows:

The members of Bunuba Aboriginal Corporation RNTBC resolve to amend **Rule 17.1 and add new Rule 17.7** of the Bunuba Aboriginal Corporation RNTBC rule book on the same or substantially the same terms as below and agreed by the members at the AGM:

17.1 General principles

- (a) This rule sets out the steps which must be taken to try to resolve any disagreement or dispute about the affairs of the corporation or how the Act or the corporation's constitution applies, which arises between:
 - (i) members
 - (ii) members and directors
 - (iii) directors or
 - (iv) the corporation and native title holders.
- (b) Procedures in these rules for resolving disputes between the corporation and a member or between the corporation and a native title holder shall be settled, as far as is possible and/or relevant in accordance with traditional Bunuba laws and customs.
- (c) When a meeting, a mediation or an arbitration is convened in accordance with these rules, the corporation, members and native title holders must attend meetings and participate in good faith in order to resolve the dispute.

17.7 Disputes between the corporation and non-members

⁽b) The dispute resolution process set out in rule 17.1-17.6 does not apply to disputes between the corporation and non-members except for in the specific circumstances set out in rule 17.7(a).

<u>Proposed Special Resolution 8:</u> Amend and add new definitions into the Dictionary at Schedule 1 as follows:

The members of Bunuba Aboriginal Corporation RNTBC resolve to amend the **Dictionary at Schedule 1** of the Bunuba Aboriginal Corporation RNTBC rule book on the same or substantially the same terms as below and agreed by the members at the AGM:

(i) Delete:

Affected native title holders means those native title holders who hold native title rights and interests that may be affected by a proposed native title decision.

(ii) Amend definition of "Native title Decision":

Native title decision means a decision:

- (a) to surrender native title rights and interests in relation to a determination area or part of a determination area or
- (b) to enter an indigenous land use agreement under Subdivision B, C or D of Division 3 of Part 2 of the Act or an agreement under Subdivision P (right to negotiate) of that Division; or
- (c) to allow a person who is not a common law holder, or a class of persons who are not common law holders, to become members of a prescribed body corporate; or
- (d) to include one or more consultation processes in the constitution of a prescribed body corporate; or
- (e) to do, or agree to do, any other act that would affect the native title rights and interests of the native title holders,

and includes a decision refusing to make a proposed native title decision.

(iii) Add definition of "Native Title Legislation":

Native Title Legislation has the same meaning as in section 700-1 of the Act.

<u>Proposed Special Resolution 9:</u> Amend Schedule 2 – Application for membership form as follows:

The members of Bunuba Aboriginal Corporation RNTBC resolve to amend the Application for membership form at Schedule 2 of the Bunuba Aboriginal Corporation RNTBC rule book on the same or substantially the same terms as below and agreed by the members at the AGM:
